CALL TO ORDER:

The regular meeting of Parks and Recreation Board was called to order at 7:30 pm by Marianne Bausinger, Chairperson.

APPROVAL OF MINUTES

UPDATES –

Eagle Scout Project – Shaw’s Bridge Park – Mr. Hamel has no response from Scouts yet. The sign is installed but nothing placed inside.

Eagle Scout Project – East Bradford Park sand box – finished- need some removal of soil around sides per Mr. Carroll.

Eagle Scout Project – Mt. Bradford Pond – Clean-up complete. Plan to start work on parking areas next. Pond inspection is in progress- including wall and springhouse.

Eagle Scout Project – East Bradford Park flag pole – John Houston of 1111 Nobb Hill Drive- an Eagle Scout plans to construct paver circle around flag pole per previous motion. It has been approved by Scouts and Mr. Titus signed off. Target to complete this fall.

OTHER BUSINESS:

WCU Subdivision- No comment.

BUDGET:

East Bradford Park- Mr. Carroll suggested budgeting for trail paving and maintenance, at least sealing. Also, new windscreens for tennis courts. Mr. Carroll will get pricing. Also wind screens for both Big League and Little League backstops. Partial fencing of volleyball court.
Pond restoration/Brandywine trail- Mr. Colley suggested budgeting 5k-10k.
Mt. Bradford- add a sign with similar look as other signs in the township.
Top of Skelp Level- widen driveway and make lot larger.
