

**EAST BRADFORD TOWNSHIP  
PARKS AND RECREATION BOARD  
May 27, 2015 Minutes**

East Bradford Township Parks and Recreation Board met on Wednesday, May 27, 2015 at 7:00 pm, in the East Bradford Township Building, 666 Copeland School Road, West Chester, Chester County, Pa., 19380.

**CALL TO ORDER:** The regular meeting of the Parks and Recreation Board was called to order at 7:00 pm by Marianne Bausinger, Chairperson.

**APPROVAL OF MINUTES:** Approval of the March 25, 2015 minutes was motioned by Joe Hamel and seconded by John Spangler, with all in favor.

**Eagle Scout Project (2 presentations)**

1. Rex Lewellyn gave a nice presentation on building 2 picnic tables (Trex for tops and seats), 1 garden bench, 1 dog ramp, and 1 set of weave poles for dog park. Specs called for 6 foot height for dog ramp, and 4 foot height was suggested by Board for preferred height. Ash Swayne and Mike Colley will provide help for oversight of the project. Target completion date is August 1, 2015.
2. AJ Marino gave a thorough presentation on a new trail to be cut in Harmony Hill Nature Area. The Scouts will provide all equipment to clear and build. It will be completed by mid-July or early August. John Spangler and Mandie Cantlin will be coordinators. The project trail is already flagged.

**STEWARDSHIP REPORT ON SUGARS BRIDGE**

Mike Colley presented motion, seconded by John Fidler to create feasibility study of restoring water flow to existing pond on former Wood property. Need to determine if pond can be fed via gravity or must be pumped.

**TRAIL COMMITTEE REPORT**

Presented by John Spangler. For upcoming Trail Blazer Run, need both runners and volunteers. Hogs Hallow Trail is the proposed name for trail at Paradise Farm Camp- recommendation only, but most favored.

**DOG PARK**

Marianne Bausinger discussed refining specific rules and regulations for dog park. Joe Hamel motioned to use AKC Rules and Regulations and modify slightly to include some additional language. Motion was seconded by John Fidler. Also, it was suggested to post a detailed explanation for each rule in a kiosk, the Township website and newsletter.

**OTHER BUSINESS**

Mike Colley recommended that the Historical Committee research the ruins at Harmony Hill Nature area so it can be included in naturalist walks.

**ADJOURN:** On motion of Ms. Bausinger and second by Mr. Swayne the meeting adjourned at 8:20 pm.
