Subject: Sale of Public Sewer System

Dear Public Sewer Customer:

In December 2017, the East Bradford Township Board of Supervisors approved an Asset Purchase Agreement with Aqua Pennsylvania, Inc. for the sale of the public sewerage system. After closing, Aqua will assume responsibility for the public sewer mains located within sewer easements and streets (not private lines to individual houses/units), the sewer pump stations, and sewer billing and collections. The Township and Aqua obtained approval from the Pennsylvania Public Utility Commission this past spring and closing is scheduled on December 12, 2018.

What does this mean to you the public sewer customer?

- You will receive your final East Bradford Township Sewer Bill dated January 1, 2019 for the period of October 1 through December 31, 2018, just after the New Year. Payment will be made directly to East Bradford Township as you have in the past and will be due 30 days after the bill date.
- If you are signed up for auto pay via e-check or credit card, your final payment will be taken out on January 10, 2019. After that date the system will be taken down so that no future payments can be made through the auto pay system.
- If you have auto pay set up through your bank, you will need to remove the information from their system after you make your last payment to the Township. Once you receive your new combination Aqua water/sewer bill, you should verify that you have the correct information in your banking system for auto pay to Aqua. If you are not on public water, you will receive just a sewer bill from Aqua.
- If you pay on-line through the Township portal, this will continue to be available to pay your current bill or any past due you may have on your Township Sewer Account until February 28, 2019.
- Your final East Bradford Township sewer bill and all past due Township Sewer Accounts must be paid by February 28, 2019 or the account will be turned over to Portnoff Law for collection.
- The Township will refund any credit balance on an account at the end of January 2019 directly to the property owner. No balances will be carried over to your Aqua account.
- Billing by Aqua will be monthly, on the same bill as your water bill, and will continue to be at a flat rate. (Again, if you do not have public water, you will only receive a sewer bill.) The current rate is required to remain until at least 2021. Your Aqua water bill in December will show sewer on the bill, with a "0" balance.
